Certification Requirements

To be completed within one year of your training date.

- Participation in a Circle of Life Coach Training Seminar (where you receive the training manual)
- Facilitating a practice group with at least 4 people minimum - for 10-12 hours minimum. This can be done in various formats.
- The purchase of 6 Guide Books
- 6 evaluations turned into the Circle of Life office (this can a combination from at least 4 group participants and 2 1-to-1 clients)
- 8 (of the 10 scheduled) sessions of 1-to-1 peer coaching calls - 15 minutes per person (each way)
- Attend or report on 3 training conference calls. You are required to participate on the one call that you signed up for at your training. The remaining two calls you can choose to attend or listen to the recording of the calls. If you choose to listen to the recorded sessions, you are required to send an email to your trainer, reporting on two things you learned from the call. There will generally be 4 scheduled Conference Calls to choose from.

To meet the requirements of certification, one must complete all these items within one year of your training date. (If not certified within 12 months, refresher training rates are available to complete certification.)

Note: Please be in contact with us DirectorOfTraining @ circleoflife.net if you are in the process of completing your qualifications for certification but you find you will not complete them within your training anniversary date (one year from your training seminar date).

RENEWAL of Certification Requirements

To be completed ANNUALLY by end of your training anniversary month.

Upon the anniversary date of your training (eg. If you trained in April 07, your anniversary date is April 08) please choose the method by which you would like to maintain your certification status.
